Privacy Statement

Tiburon Research SIA, a company registered in Latvia under number 40103670887, with principal place of business at 10 Krišjāṇa Barona iela 32-12, Rīga, LV-1011 ("Tiburon Research" or "Company") is a technology provider helping businesses to conduct their market research studies and to enhance their business decision making process.

This Privacy statement ("Privacy Policy") explains how we use personal data we collect about you, when you access, register and use our services via www.ludi.today website ("Site"). Please read it carefully. By using our Site, you consent to this Privacy policy.

1. What information do we collect about you

When using our Site you are normally asked to provide your opinion on various facts, situations, your personal experience, your preferences, etc.

We collect the personal data ("information") you provide by email and in completing our recruitment questionnaire when joining our Site.

2. Why we collect personal data from you

The primary purposes, why we collect personal data from you is the conduct of surveys on the Site.

We take reasonable measures to help protect personal data about you from loss, theft, misuse and unauthorized access, disclosure, alteration and destruction. All personal data you provide to us is encrypted and stored on our secure servers behind firewalls.

4. Personal data, processed with automated means. Tracking
